




# Clearing Your Forders

# **STUDENT PARKING ON SCHOOL GROUNDS – 2019**

- Student may apply for a parking permit for parking on the school grounds. These applications are available from the Head Teach Admin who will also receive, process and issue applications and permits.
- Students must have permission from their parents it they wish to drive to school and park on the school grounds.
- Permits are not automatically issued and will be immediately withdrawn if rules are breached.
- Permits must be displayed on the **DASHBOARD** of your car or permission to park on school grounds **will be withdrawn**.
- The car park is out of bounds at all times unless a student is arriving at school or leaving school.
- No driver is to leave the school during school hours unless they have finished lessons.

### **GEORGES RIVER COLLEGE - OATLEY CAMPUS** STUDENT DRIVING and CAR POLICY

Many senior students drive to and from school. Senior students may also request permission to drive a car during school hours or to and from school related venues e.g. Sport, excursion, TAFE. We are happy to approve this as long as we know the student's parents are aware and the student accepts the responsibility to be a careful driver.

No passengers are to be carried unless a letter has been received from that student's parents stating that they give permission for their son or daughter to drive with a friend and that they accept all responsibility.

Breaking this rule or irresponsible driving will mean immediate loss of driving privileges. The school immediately notifies parents if a student driver or passenger acts irresponsibly or endangers the lives of others.

## RULES

- Student may apply for a parking permit for parking on the school grounds. These applications . are available from the Head Teach Admin. Miss Gemisi who will also receive, process and issue applications and permits.
- Students must have permission from their parents it they wish to drive to school and park on the school grounds.
- Permits are not automatically issued. If rules are breached, the student will be counselled and parents notified. Further breaches will result in the permit being withdrawn, a ban placed on the car or possible impoundment.
- Permits must be displayed on the DASHBOARD of your car or permission to park on school grounds will be withdrawn.
- The car park is out of bounds at all times unless a student is arriving at school or leaving school.
- No driver is to leave the school during school hours unless they have finished lessons.
